Worth, his wife, of Wake County., T.G. McAlister, a

single man, of Randolph County, Ella B.McAlister and

her husband, C.C.McAlister, and Charges G.Rose,

Trustee, of Cumberland County, THE PEOPLES SAVINGS BANK & TRUST COMPANY, a corporation, and MURRAY G.JAMES, TRUSTEE, of the City of Wilmington, and A.W.McAlister, of the City of Greensboro, all of the State of North Carolina, of the first part, and the CITY OF FAYETTEVILLE, a municipal corporation duly organized and existing under the laws of the State of North Carolina, of the second part,

WITNESSETH: That the parties of the first part, for and in consideration of the sum of One Dollar, to them in hand paid by the party of the second part, as wll as for other good and valuable considerations, and especially the covenants and agreements hereinafter set forth, have bargained and sold, and by these presents do bargain, sell and convey unto the party of the second part, and its successors, an easement or right-of way for street and highway purposes upon and over that strip of land located in Cross Creek Township, Cumberland County, North Carolina, in the southeast portion of the City of Fayetteville, bo bounded and more particularly described as follows:

## FIRST RIGHT-OF-WAY

Station 00+00 which is located on the center line of the right-of-way or easement, is also on the western line of the property conveyed to the City of Fayetteville by certain of the parties of the first part by deed registered in Book 378, eage 161, and is South 5\*.

40. West 30 feet from the Southwest corner of the tract of land belonging to the Atlantic Coast Line Railroad Company, and the northwest corner of the property described in the above deed, the said property corner is marked with a railroad "T" iron, with two pine pointers;

Beginning at a point 20 feetfrom and at right angles to the center of line of the right-of-way or easement, and on the North side of said center line, and in the western line of the tract conveyed to the City of Fayetteville, and runs thence South 89\* 37' West 20 feet from and parallel with the center line of said right-of-way 428.10 feet to a stone station marked 4+ 28.10; thence with a 41\* 42' curve to the right, 20 feet from and parallel to the center line of said right-of-way 191.60 feet to a stone station marked 6+19.70; thence North 10\* 29' West, 20 feet from and parallel with the center line of the said right-of-way, 798 feet to the northern line of the property belonging to T.G. McAlister and Hal V. Worth, it also being the southern line of the Atlantic Coast Line Railroad Company property thence at right angles to saidright-of-way line, South 79\* 30' West 20 feet to the center line of said right-of-way, it being also the center line of Kinty Street extended; thence along the center line of said right-of-way and the center line of King Street extended, South 10\* 29' East 187 feet to a corner of the property belonging to McAlister and Worth, in the center of King Street extended; thence South 79\* 31! West 20 feet to a stake in the line of the property belonging to Worth and McAlister; thence South 10\* 29! East 20 feet from and at right angles to the center line of said right-of-way, and parallel with said center line oil feet to a stone station marked o+19.70, the point of a 41\* 42' curve; thence with the curve reversed to the left, 191.60 feet to a stone station marked 4+28.10, the beginning of the curve; thence parallel with and 20 feet from the center

line of said right-of-way, North 89\* 37' East 428.10 feet to a stone in the Western line of the property conveyed to the City of Fayetteville; thence with the western line of said property crossing the center line of the the right-of-way, North 5\* 30' East 40 feet to the beginning.

## SECOND RIGHT-OF-WAY:

BEGINNING at the stone station marked 6+19.70 in the above description of the first right-of-way above described, known as the right-of-way of King Street extended and on the west edge of said right-of-way, and runs thence South 10\*29! East 275 feet to a stake; thence South 4\* East 1305 feet to the southern boundary of the City of Fayetteville; thence with the southern boundary line of the City of Fayetteville, in a southeasterly direction, about 45 feet to a stake in said southern boundary line so as to provide a right-of-way 40 feet wide; thence North 4\* West about 1355 feet to a stake; thence North 10\* 29! West 165 feet to the intersection with the Southern boundary line of the right-of-way #1, described above on a portion of the curve above described; then with a 41\* 42! curve in an a northwesterly direction along the boundary line of right-of-way #1, described above to the beginning.

See plat of both of said right-ow-ways hereto attached, and made a part of this deed.

The right-of-way or easement herein conveyed is intended to comply with and include the right-of-way or easement 30 feet wide, referred to in the deed from certain of the parties of the first part to the City of Fayetteville, dated February 15th, 1934, and registered in Book 378, page 161. And this conveyance is also intended to include the right-of-way or easement granted by certain of the parties of the first part to the Gulf Refining Company, by deed dated June 15th, 1935, and registered in Book 385, page 95.

Ella B.McAlister and C.C.McAlister, her husband, and Charles G.Rose, Trustee, join in this conveyance only for the purpose of releasing any interest they may have in said right-of-way hereby granted under the terms of a deed of trust dated September 14th, 1935, and registered in Book \_\_\_\_\_, Page\_\_\_\_\_, registry of Cumberland County.

THE PEOPLES SAVINGS BANK & TRUST COMPANY and Murray G.James, Trustee, join in this conveyance only for the purpose of releasing any interest they may have in said right-of way hereby granted under the terms of a deed of trust dated May 6th, 1932, and registered in Book 370, page 470.

A.W. McAlister joins in this conveyance for the purpose of releasing any interest he may have in said right-of-way hereby granted under the terms of a mortgage deed dated February 27th, 1930, and registered in Book 360, page 595.

TO HAVE AND TO HOLD said right-of-way or easement to the said party of the second part, and its successors, under the following vovenants and agreements:

## FIRST:

Should said street or right-of-way be hereafter paved, the City of Fayetteville or its successors, shall not have the power or authority to assess the costs of such paving to the present or any future owners of the property abutting on said street or right-of-way.

SECOND: SAID street or right of way shall be kept open and maintained by the City of Fayetteville, or its successors for the use and benefit of present or any future owners of adjoining property, and for the use and benefit of the general public.

THIRD: Should the said street or right-of-way or any part thereof be hereafter abandoned and ceased to be used for the purposes herein intended, the said property shall

474revertato the abutting property owners.

The said Hal V. Worth and Marguerite M. Worth, his wife, and T.G. McAlister covenant to and with the party of the second part, and its successors, that they are seized of said preperty in fee; that the same is free and clear from all encumbrances, and that they will warrant and defend the title to the same against the lawful claims of all persons whomsoever.
